1. Objectives of the ICC

- a) Prevention and prohibition of sexual harassment
- b) Redressal of complaints in a **fair, impartial, and confidential** manner
- c) Awareness creation on gender sensitization and POSH compliance
- d) Ensuring a safe academic and working environment

3. Tenure of the Committee

4. Scope & Jurisdiction

The ICC shall address complaints related to:

- a) Teaching staff
- b) Non-teaching staff
- c) Students
- d) Contractual, temporary, or outsourced employees
- e) Incidents occurring **within campus or during official activities**

5. Powers & Functions

- a) Receive written complaints of sexual harassment
- b) Conduct inquiry following principles of natural justice
- c) Summon witnesses and examine documents
- d) Recommend appropriate disciplinary action
- e) Submit annual report to the Management / District Officer

6. Complaint Redressal Process

- a) Complaint to be submitted within **3 months** of incident
- b) Acknowledgment by ICC
- c) Inquiry completed within **90 days**
- d) Recommendations submitted to Management
- e) Action taken within **60 days**

7. Confidentiality Clause

All proceedings, identities, and records of complaints shall be treated as **strictly confidential**.

Any violation will attract penal action under the Act.


